# REQUEST FOR CONFIRMATION

Dear Candidate,

Thank you for presenting yourself for reception of the Sacrament of Confirmation.

In the Sacrament of Baptism, you were born again as a child of God and began your Christian journey. When your parents presented you to be baptised, they made a promise to bring you up in the practice of the faith, by loving God and loving your neighbour; in the Sacrament of Confirmation, you make for yourself those promises, and the grace of Baptism is firmed up, or confirmed, when you are sealed with the Gift of the Holy Spirit so that you can live our your Baptism in your daily life.

At the very heart of our living-out of the faith is the celebration of Sunday Mass, in which we gather as the Christian community around the Altar of God to offer him worship, are challenged by Sacred Scripture to become more like Christ, present our offerings of bread and wine which become the Body and Blood of Christ and receive them in Holy Communion so that we may be given the grace to announce the Gospel of the Lord and glorify the Lord in our daily lives.

Please be assured of my prayers for you as you prepare to receive the Sacrament of Confirmation, and my hope that the preparation course will help you to develop your faith,

**Baptism:** You must have been baptised in order to receive the Sacrament of Confirmation; if you have not yet received the Sacraments of Baptism, Reconciliation and the Blessed Eucharist, please see Fr Andrew.

Please attach your certificate of Baptism to this form.

Mass Attendance: Those who wish to receive the Sacrament of Confirmation should be attending one of the Sunday Masses in this parish during their confirmation preparation.

**Age:** You must be in Key Stage 3 or above when to receive the Sacrament of Confirmation in this parish on *Friday 6<sup>th</sup> June 2025.* 

Welcome Meeting: All candidates and their parents/carers must attend the welcome meeting, which will be held in Holy Trinity Parish Hall, next to Corpus Christi Church (The date of which will be confirmed via email). At that meeting: the catechetical course will be presented; our expectations of participants will be explained; and course materials will be distributed. There may be costs attached to the purchase of materials but this will be communicated in good time prior to the welcome meeting.

Preparation for Reception of the Sacrament of Confirmation: Your child will be expected to participate in *around* thirteen catechetical sessions. The locations, dates and times of these sessions will be confirmed once the catechetical team confirms the number of candidates presenting themselves. They will also be expected to celebrate the Sacrament of Reconciliation before they are confirmed, and to write to Fr Andrew to explain why they wish to receive the Sacrament of Confirmation and why they have chosen their Confirmation name.

Flame 2025: As part of the preparation programme, your child will be expected to take part in CYMFED Flame 2025, further details regarding this retreat will be provided at the welcome meeting. This will be subsidised by the parish but there may be additional costs per candidate, again this information will be explained in detail at the welcome meeting.

**Sponsor:** Everyone who is to be confirmed must have a sponsor; it could be your child's godparent from their Baptism, and their gender does not matter. A sponsor must be a practising Catholic, at least sixteen years old, confirmed, made their First Holy Communion and attends Sunday Mass regularly. You will be asked to confirm that your child's sponsor is a practising Catholic.

**If you do not live in this parish**, please speak to your parish priest before completing this form, since Confirmation *should* be celebrated in the child's own parish church.

Once this form has been completed by the candidate, the candidate must give it, ideally, to Fr Andrew. If this is not possible then a steward or deliver it to the presbytery. This should be done no later than Sunday 8<sup>th</sup> September 2024; as Fr Andrew must countersign the form.

The lawful basis for sharing your personal data within the Diocese only is the legitimate interest of Parish and Diocese administration.

Your personal data:

- will be used to inform you about news, events, fundraising and activities within the Diocese.
- will be seen by the Parish Priest and Parish Office employees and volunteers.
- will not be shared with anyone external (i.e. a contractor) unless it is a legal obligation or within the legitimate interests of the Diocese.
- will not be used for any other purpose than for providing Parish and Diocese information and for Parish and Diocese administration unless it is a legal obligation or within the legitimate interests of the Diocese.
- will be stored on the Diocese secure sever accessed by password login; any paper records will be stored in a lockable cabinet in lockable office; sensitive personal data (e.g. for under 18s) will be saved in a password encrypted file.
